Description/Scope of Work:

COMMERCIAL MISCELLANEOUS

DESCRIPTION OF WORK: Tesla is proposing to install an electric vehicle charging station within existing parking lot. The project includes the installation of (16) Charging posts, (4) charging cabinets, (1) switchgear, (1) utility transformer and (1) utility meter. Also relocating one light pole. 12-2527A-AMND

The slope of the walking surfaces used to access the charging station cannot exceed 2% slope. ICC A117.1. Section 302.

A 30 inch x 48 inch clear floor space for forward or parallel approach must be provided for access at the charging station. 2009 ICC A117.1 Section 305.

NOTE: vehicle wheel stops, and bollards cannot encroach into the required clear floor space.

Reach ranges at the charging station shall comply with one or more of the following from 2009 ICC A117.1 Section 308. Vehicle wheel stops and bollards shall be taken into consideration for compliance with reach ranges. For a forward reach a maximum reach height is 48 inches with a maximum reach depth of 20 inches or a maximum reach height is 44 inches with a maximum reach depth of 25 inches. For an unobstructed side reach on a parallel approach a maximum reach height is 48 inches where the edge of the clear floor space is 10 inches maximum from the element over and element a maximum of 34 inches high. For an obstructed side reach on a parallel approach a maximum reach height is 46 inches where the edge of the clear floor space is 24 inches maximum from the element over and element a maximum of 34 inches high.
