1. Be the legal and registered owner of a Model S or Model X vehicle that currently has free unlimited Supercharging included at the time of delivery of the new Model S or X. For EMEA only: Those on an Operational Lease with third-party Lease and Fleet Management companies are ineligible, unless they first purchase the vehicle from the leasing company.
2. Order and take delivery of your new titled Model S or Model X between April 20, 2023 and June 30, 2023.
3. Accept the forfeiture of the free unlimited Supercharging benefit on your current Model S or Model X. Alternatively, you can choose to trade-in your current vehicle altogether directly with Tesla when you purchase your new Model S or Model X.
